

PTC'07 EXHIBITOR BADGE FORM **Deadline: 30 November 2006**

Each 8'x10' booth space is allowed up to 6 complimentary Exhibitor Badges. Additional badges may be purchased for \$20 each. Exhibitor Badges and tickets will be included in the Exhibitor Packet available at the Exhibitor Registration desk in the Coral Lounge, 6th Floor of the Mid-Pacific Conference Center. Indicate below, the exhibitor responsible for the exhibitor packet onsite. Please review the Booth Personnel information of the RULES AND REGULATIONS, section #7.

- Exhibitor Badges allow registered booth personnel (see below) access the Mid-Pacific Marketplace during installation/dismantling of booths and official exhibit hours. Exhibitors that wish to attend the full conference sessions, tutorials/workshops, round tables, etc., must register for the conference separately and pay the appropriate member/non-member conference registration fee.
- Booth personnel are required to wear their badges at all times while in the Mid-Pacific Marketplace. **BADGES ARE NON-TRANSFERABLE. PTC staff and security will refuse entry and escort out any person not wearing an appropriate badge.** PTC reserves the right to confiscate misused booth-personnel badges
- Booth personnel are classified as exhibitor representatives who are engaged in the display, demonstration and sales of the company's products or services. If you have staff or individuals who will be involved only in the set-up of your exhibit display, please furnish their names on a separate sheet of paper to PTC in advance. A temporary pass will be issued to each of these individuals at the Exhibitor Registration Desk. Exhibitors may not permit non-exhibiting company representatives to exhibit in their booth.
